Original Passport with old Passport

Note : Passport Should Be Valid Minimum 06 Months From The Date Of Travel, Passport Has Been Issued Within 10 Years And Validity Must Not Exceed 10 Years, No Hand Written Passports Will Be Accepted And At Least 2 Blank Pages



Evidence of Sufficient Funds

- 03 years Personal Income Tax Returns with computation of Total Income Page
- 06 months Personal original Bank Statement updated with sufficient balance
- Copy of Investments like (P.P.F., Share Demat A/c Statement, F.D., L.I.C. Surrender value, etc.)
- C. A. Certification of your total movable Property



National id proof - Color Copy

Aadhar card copy (mandatory)
Personal Pan card copy

If applicant is Employee

- Pay Slip (last 6 months)
- Leave sanction letter and N.O.C.

If applicant is Self Employee

- Business letterhead with sign & stamp & visiting card
- Business Proof (Shop & Establishment, G.S.T., C.S.T., etc.)
- Partnership Deed
- Memorandum of Article
- 03 Years Income Tax Return with computation of Total Income Page
- 06 Months Bank Statement

If applicant is Retired

- Retirement letter from Employer
- Pension passbook copy

If applicant is Student

- Bonafide Certificate
- College or university I D Card copy

If Professional Person - Like Doctor, C.A., Advocate, Architect

- Degree Certificate
- Any other Registration Certificate (Ex.: G No Certificate, Bar Council Certificate etc...)

- Applicants are requested not to give any Original documents except our necessary demand.
- We will take 3 to 4 days to prepare visa application to submit online.
- Applicant should not purchase non-refundable tickets or accommodation prior to visa issue. Any such purchases are the sole responsibility of the applicant only. We recommend instead that you lodge your visitor/Tourist application well ahead of your purpose travel date and finalize travel arrangements after visa issue.
- Visa issuance is sole responsibility of Australian High Commission; Best Voyage is not responsible for any rejection/refusal or delay in visa.
- Australian High Commission may call applicant for interviewing and ask purpose of visit, available funds and occupation.
- All Documents Must in English and A4 size.
- Applying for a visitor visa with you might need to have health examinations.
- Whether you need them, and what examinations you need, depends on :
 - the visa you are applying for
 - how long you plan to stay in Australia
 - what you plan to do in Australia
 - any special circumstances that might apply to you
 - whether you have any significant medical conditions
